# 2023 ANNUAL BUSINESS MEETING MINUTES FRIDAY, AUGUST 18, 2023 10:30AM to 11:45AM (EDT) SHERATON PHILADELPHIA DOWNTOWN HOTEL Room: PHILADELPHIA BALLROOM

ITEM #1 – CALL TO ORDER Society President Shirley A. Jackson called the meeting to order.

ITEM #2 – ADOPT (REVISE) AGENDA The agenda was adopted as presented.

ITEM #3 – REVIEW OF THE BY-LAWS CHANGES AND ANY PROPOSALS FOR FURTHER CHANGE Valerie Leiter presented on behalf of By-Laws Chair Tracy Dietz the By-Laws changes over the past year, and one (1) change was proposed. An amendment to Article VI, Section 1B changed the nominations process for service positions. There are no pending By-Laws changes at this time.

## **RESOLUTION 2: SSSP to Oppose State Interference with Academic Freedom**

WHEREAS, democracy relies on freedom of speech,

**WHEREAS**, college and university classrooms are important spaces for the engagement with and discussion of important social issues under the terms of academic freedom without state interference,

**WHEREAS**, the production and dissemination of academic knowledge contains within it a set of checks and balances, including disciplinary standards for conducting research, the peer review process, and department- and institutional-level review of curriculum and pedagogy that assure empirical rigor and responsible teaching,

**WHEREAS**, state interference in the production and/or dissemination of academic knowledge is a threat to democracy and the advancement of society,

**WHEREAS**, several state legislatures have drafted and will likely pass bills that limit educators from teaching certain concepts and ideas, including but not limited to theories and research that present inequalities based in social systems such as race, ethnicity, gender, sexuality, etc. as well as the intersections of these systems as operating through social structures and institutions,

**WHEREAS**, these and other bills also prohibit colleges and universities from recruiting faculty from diverse backgrounds as well as those whose work amplifies marginalized perspectives and voices,

**WHEREAS**, the operation of power and inequalities through social structures and institutions has been documented in decades of social science research and the coverage of which is central to the sociological study of social problems,

**WHEREAS**, the production and dissemination of such knowledge prepares college students for job markets in myriad fields,

**WHEREAS**, the Society for the Study of Social Problems (SSSP), the American Association of University Professors (AAUP), the American Sociological Association (ASA), and other professional organizations already have public statements supporting academic freedom,

**THEREFORE BE IT RESOLVED**, that the Society for the Study of Social Problems (SSSP) will produce a statement explaining the social-scientific understanding of structural and institutional inequalities, affirming the importance of academic freedom, defending initiatives to diversify faculty, and denouncing state interference, and publish the statement on their website, and

**BE IT RESOLVED**, that the Society for the Study of Social Problems (SSSP) will collaborate with leaders of other organizations in the discipline, including but not limited to the American Sociological Association, to sign on to the statement or produce, publish, and disseminate a similar one, and collaborate with organizations in other disciplines to do the same, and

**BE IT RESOLVED**, that the Society for the Study of Social Problems (SSSP) will send the statement to multiple news outlets, including but not limited to *The New York Times*, *Washington Post*, and *Huffington Post*.

#### **RESOLUTION 3: Support Gender-Affirming Healthcare**

*Whereas,* gender-affirming healthcare is associated with positive mental health and social experiences and decreased rates of depression, suicidal ideation, and attempted and completed suicide for transgender and gender-diverse adolescents and young adults,

*Whereas,* several U.S. states are enacting bans on gender-affirming healthcare for transgender and gender-diverse adolescents and young adults,

*Whereas,* legislative bans politicize healthcare access and perpetuate stigma and social exclusion for transgender and gender-diverse people,

*Whereas,* legislative bans disproportionately impact racial/ethnic minoritized groups and people who have limited economic and other resources that would allow them to otherwise obtain gender- affirming healthcare,

**THEREFORE** *Be it Resolved*, that the Society for the Study of Social Problems (SSSP) will join the Society for Adolescent Health and Medicine,<sup>2</sup> American Public Health Association,<sup>3</sup> American Academy of Pediatrics,<sup>4</sup> American Academy of Family Physicians,<sup>4</sup> American College of Physicians,<sup>4</sup> American College of Obstetricians and Gynecologists,<sup>4</sup> American Osteopathic Association,<sup>4</sup> American Psychiatric Association,<sup>4</sup> American Medical Association,<sup>5</sup> American Nurses Association,<sup>6</sup> American Psychiatric Association,<sup>7</sup> in writing a statement affirming support for gender affirming healthcare, and

*Be it Resolved,* that the Society for the Study of Social Problems (SSSP) will communicate support for gender affirming healthcare to the leaders of both parties in the U.S. House of Representatives

and the U.S. Senate, the President of the United States, and the governors and departments of health in states where gender-affirming healthcare is under attack<sup>8</sup>.

#### **RESOLUTION 4: Guaranteeing and Furthering Socio-Economic Rights**

WHEREAS, the Society for the Study of Social Problem (SSSP)'s purpose includes "to foster higher quality of life [and] social welfare;"<sup>i</sup> and,

WHEREAS, SSSP affirms the principles of the Universal Declaration of Human Rights of 1948,<sup>ii</sup> recognizing that human have inherent dignity that must be afforded to us; and,

WHEREAS, human flourishing requires basic needs are met, such as nourishment (e.g., nutritious food and clean water), shelter (e.g., safe and stable housing), clothing, quality and comprehensive healthcare, safe and healthy working conditions and rights to collective bargaining, educational equity and access, from preschool through postsecondary education, and highspeed internet access; and,

WHEREAS, the United States is one of the wealthiest countries in the world, yet also one of the most unequal;<sup>iii</sup> and,

**WHEREAS**, over 1 in 10 U.S.-Americans are below the official poverty rate, and poverty rates and impacts differ across the country by various social locations and their intersections (e.g., race, citizenship, disability status, population density, gender, sexuality);<sup>iv</sup> and,

WHEREAS, life expectancy in the United States is declining;<sup>v</sup> and

**WHEREAS**, President Franklin D. Roosevelt recognized in his 1944 State of the Union that the current Bill of Rights on its own is insufficient, and that U.S.-Americans also require basic economic rights;<sup>vi</sup> and,

**WHEREAS**, in 1977, President Jimmy Carter signed the International Covenant on Economic, Social and Cultural Rights, adopted in 1966, on behalf of the United States;<sup>vii</sup> and,

**WHEREAS**, in 2021, Congresspersons Alma Adams, Jan Schakowsky, and Ilhan Omar introduced legislation to the 117<sup>th</sup> Congress to amend the U.S. Constitution to guarantee U.S.-Americans' rights to housing, health care, education, and nutrition;<sup>viii</sup>

**NOW, THEREFORE, BE IT RESOLVED**, that SSSP affirms it is the U.S. government's obligation to guarantee its residents basic socio-economic rights; and,

**BE IT RESOLVED**, that SSSP urges the U.S. Senate to ratify the International Covenant on Economic, Social and Cultural Rights; and,

**BE IT RESOLVED**, that SSSP urges Congress to propose amending the U.S. constitution to guarantee basic economic rights; and,

**BE IT RESOLVED**, that SSSP urges candidates for public office in the United States, including the 2024 U.S. presidential candidates, to support the above initiatives, to declare that basic socio- economic needs are human rights everyone deserves without exception, and to recognize this in their platforms through a robust policy agenda to end unnecessary suffering and support human flourishing; and,

**BE IT RESOLVED**, that SSSP will share a copy of this resolution with the President of the United States of America, Speaker of the U.S. House, U.S. House Majority Leader, U.S. House Minority Leader, U.S. Senate President Pro Tempore, U.S. Senate Democratic Leader, and U.S. Senate Republican Leader.<sup>ix</sup>

ITEM 5 – REVIEW OF THE MINUTES FROM LAST YEAR'S MEETING

ITEM 6 – REPORT FROM THE SECRETARY SUMMARIZING 2022-2023 BOARD ACTIONS Secretary Glenn Muschert summarized the 2022-2023 Board Actions.

ITEM 7 - REPORT FROM THE EDITORS OF SOCIAL PROBLEMS

Annulla Linders, Editor of *Social Problems*, reported on the state of the Society's journal over the past year. The Editors thanked all who make the journal possible, including authors, reviewers, editorial staff, associate editors, advisory board members, and members of the student social media committee. In addition, the Editors acknowledged the support of various parties.

The members present congratulated and thanked the Editors for their outstanding stewardship of *Social Problems*.

ITEM 8 – REPORT FROM THE TREASURER ON THE FINANCIAL CONDITION OF THE SOCIETY Heather E. Dillaway, Treasurer, reported that the financial state of the Society is strong. Overall, the organization is stewarded effectively and runs in a financially responsible way. The Treasurer mentioned the many parties who made this possible. The investments of the Society amount to roughly \$1 million, with fluctuations according to market conditions. The concern remains that, since the COVID-19 pandemic, the Society has operated at a deficit. For example, in 2023 the Society will incur a predicted

\$200K budget deficit. The Society has weathered this and other recent shortfalls by tapping gains on its investments, a practice that is not feasible for the long term. Thus, the Society is at an inflection point, and there is a need to address this risk to the long-term financial health of the SSSP. The Treasurer made it clear that the long-term viability of the Society relies on balancing its financial statements. While the Society has operated at a financial deficit in recent years, the Treasurer clarified that the Society's financial auditors gave the Society a clean bill of health, with no unusual findings.

## ITEM 9 - REPORT FROM THE EXECUTIVE OFFICER

Elroi J. Windsor presented the report from the Executive Officer (EO), beginning with a statement of gratitude for the opportunity to serve. The EO thanked Héctor Delgado and Susan Carlson for their stewardship of the Society before transitioning into the position. EO offered appreciation to those who contribute to the Society and the staff in the Administrative Office. The EO is particularly interested to hear from new, current, and former members about what keeps them engaged. As the members are the organization's heart, this is a priority, including maintaining and enhancing an inclusive environment. The EO is working to build connections to other organizations that share our interests, including scholarly organizations and beyond. Revenue generation is a priority, in order to preserve the Society for the future. EO indicated it has been an honor to serve in this position and thanked those who assist them in the role.

## ITEM 10 - REPORT FROM THE ADMINISTRATIVE OFFICER AND MEETING MANAGER

Michele Koontz presented the report from the Administrative Officer (AO) and Meeting Manager (MM). The AO mentioned the valuable work of those involved in developing the program for the 2023 annual meeting. This is the second in-person meeting since 2019, and the AO has worked closely with the conference hotel to keep costs contained while offering benefits to the attendees. The annual meeting attendance has c. 588 attendees, with 55% in the professional category, 42% in the student/unemployed/underemployed categories, and an additional 3% exempt. There will be 113 sessions offered over the next 3 days, and an additional 3 workshops offered on the day following the close of the annual meeting. Total membership is down 14% from the previous year, and this decline has been consistent in recent years. The highest dues category is the only membership category that continues to renew at the same level as seen in 2022. Thirty-seven percent of members are students. The AO mentioned with gratitude the work of those who assist in the operation of the SSSP.

## ITEM 11 – ANY OTHER BUSINESS

President Shirley A. Jackson raised the issue of future meetings and their format. She encouraged the membership to attend the upcoming town hall meeting to discuss issues of relevance for the long-term health and functioning of the SSSP.

ITEM 12 – INTRODUCTION OF THE NEW PRESIDENT AND PASSING OF THE GAVEL Society President Shirley A. Jackson (2022-2023) introduced rising President Mary Bernstein (2023-2024) and passed the gavel.

ITEM 13 – INCOMING PRESIDENT ANNOUNCES THE SITE, DATE, AND THEME FOR THE 2024 MEETING Society President Mary Bernstein announced that the 2024 Society for the Study of Social Problems annual meeting will occur in Montréal from August 9 to 11, 2024. The theme for the conference will be "Toward a Sociology of Violence." The President introduced Claire Renzetti as Program Chair and Committee Members Ligaya Lindio McGovern, Raja Staggers-Hakim, and Dolores Trevizo.

## ITEM 14 – ADJOURNMENT OF THE BUSINESS MEETING

There being no further business, President Mary Bernstein adjourned the 2023 business meeting.
