Proposed Division Name Change Poll Reminder

• Reminder to complete poll on the division's current name of Sociology & Social Welfare to Sociology, Social Work and Social Welfare has been proposed to better reflect the breadth of the Division's membership.

Proposed Mission Statement Revision

- A change was proposed to the division's mission statement (addition of the words "and practice" to be more inclusive of the diverse interests of members. The revision is: Our division fosters the interdisciplinary connection between sociology and social work praxis. We promote theory-informed, applied scholarship on social institutions, and processes. Our mission is to aid understanding, and also to speed remedy of inequality, exclusion, and oppression through research-based policy and practice interventions.
- The proposal was approved.

Discussion of 2025 Annual Meeting Session Ideas (potential sole- and co-sponsored sessions)

- For next year's meeting the Division needs to identify 1-2 division-sponsored sessions and up to 5 co-sponsored sessions. Erica Jablonski had preliminary discussions with multiple divisions around potential co-sponsorships.
