ITEM #1 – CALL TO ORDER

Society President Mary Bernstein called the meeting to order at 10:38 am.

ITEM #2 – ADOPT (REVISE) AGENDA

The agenda was adopted as presented.

ITEM 5 - REVIEW OF THE MINUTES FROM LAST YEAR'S MEETING

Secretary Glenn Muschert presented the minutes of the 2023 Society Business Meeting.

ITEM 6 – REPORT FROM THE SECRETARY SUMMARIZING 2023-2024 BOARD ACTIONS Secretary Glenn Muschert summarized the 2023-2024 Board Actions.

ITEM 7 – REPORT FROM THE OUTGOING EDITORS OF SOCIAL PROBLEMS

Annulla Linders, Outgoing Editor of *Social Problems*, reported on the state of the Society's journal over the past year. The Editors thanked all who made the journal possible, including authors, reviewers, editorial staff, associate editors, advisory board members, and members of the social media committee. The journal is in good standing and academically strong. The Outgoing Editors have assisted the effective transition of the journal's management to the Current Editors.

ITEM 8 – PRESENTIONS BY THE EDITORIAL AND PUBLICATIONS COMMITTEE

On behalf of Editorial and Publications Committee, President Mary Bernstein presented the Outgoing Editors of *Social Problems* with a token of appreciation. The members present congratulated and thanked the Outgoing Editors for their outstanding stewardship of *Social Problems*.

ITEM 9 – REPORT FROM THE NEW EDITORS OF SOCIAL PROBLEMS

On behalf of the Incoming Editors of *Social Problems* (Andrew S. Fullerton, Michael A. Long, Rachel M. Schmitz, and Kelley J. Sittner), Editor Kelley J. Sittner addressed the members present. The stewardship of *Social Problems* has effectively transitioned to new leadership.

ITEM 10 - REPORT FROM THE TREASURER ON THE FINANCIAL CONDITION OF THE SOCIETY

Heather E. Dillaway, Treasurer, reported that while the financial state of the Society appears strong, the SSSP is facing a financial crisis threatening its long-term viability. The Society's investments amount to c. \$895K, with fluctuations according to market conditions. For several years, the SSSP has operated at a deficit. For example, in 2024 the estimated budget deficit for 2024 is c. \$182K. Declining revenue from membership dues, journal subscriptions, and meetings is a concern. The SSSP has weathered several years of budget shortfalls by tapping into its investments, a practice that is not feasible for the long term. Thus, the Society is at an inflection point, and there is a need to address this risk to the long-term financial health of the SSSP. The Treasurer made it clear that the long-term viability of the Society relies on balancing its financial statements. While the Society has operated at a financial deficit in recent years, the Treasurer clarified that the Society's financial auditors see the organization as financially stable, and they gave the Society a clean bill of health, identifying no unusual findings. Overall, the organization is stewarded effectively and runs in a financially responsible way.

Sub-Item A – Propose, Discuss, and Vote on 2025 Membership Dues Increase Treasurer Heather E. Dillaway discussed the proposed membership dues increase for 2025, which the Board approved at its August 8, 2024, meeting. Due to low attendance and not having a quorum at the Business Meeting, a vote on the dues increase was impossible. The membership will vote on the membership dues increase via electronic ballot in September, as per the following section of the By-Laws:

Article III. Membership, Section 2. Dues:

The Board of Directors may, by a majority vote of its total voting membership, propose changes in the membership dues of the Society. All such proposed changes shall be submitted for ratification at the annual business meeting of the Society. They shall take effect if approved by a

two-thirds vote of the business meeting. If they fail of approval by a two-thirds vote, the Board of Directors may submit the proposed changes to an electronic ballot of the total membership, and they shall take effect if approved by a majority voting in the electronic ballot. The electronic ballot shall remain open for sixty days and the results tabulated and verified by the Elections Committee.

ITEM 11 - REPORT FROM THE EXECUTIVE OFFICER

Elroi J. Windsor presented the report from the Executive Officer (EO), beginning with a statement of gratitude for the opportunity to serve. EO offered appreciation to those who contribute to the Society and the staff in the Administrative Office. The EO is interested to hear from new, current, and former members about what keeps them engaged. As the members are the organization's heart, this is a priority, including maintaining and enhancing an inclusive environment. This year, there were major activities involving *Social Problems*, especially renewing the contract with Oxford University Press and the transition of the journal's editorship to a new team. The EO is working to build connections to other organizations that share our interests, including scholarly organizations and beyond. The SSSP is actively engaged in efforts to economize and reduce costs. Revenue generation is a priority, to preserve the Society viability for the future. The EO indicated it has been an honor to serve in this position and thanked those who assist them in the role.

ITEM 12 - REPORT FROM THE ADMINISTRATIVE OFFICER AND MEETING MANAGER

Michele Koontz presented the report from the Administrative Officer (AO) and Meeting Manager (MM). The AO mentioned the valuable work of those involved in developing the program for the 2024 annual meeting. The AO has worked closely with the conference hotel to keep costs contained while offering benefits to the attendees. The annual meeting attendance has c. 535 attendees, with 53% in the professional category, 43% in the student/unemployed/underemployed categories, and an additional 4% exempt. Total membership is down 4% from the previous year, and this decline is less than that observed in recent years. The AO mentioned with gratitude the work of those who assist in the operation of the SSSP.

ITEM 13 - ANY OTHER BUSINESS

There was no other business raised at the meeting.

ITEM 14 - INTRODUCTION OF THE NEW PRESIDENT AND PASSING OF THE GAVEL

Society Mary Bernstein (2023-2024) introduced rising President Rose M. Brewer (2024-2025) and passed the gavel.

ITEM 15 – INCOMING PRESIDENT ANNOUNCES THE SITE, DATE, AND THEME FOR THE 2025 MEETING Society President Rose M. Brewer announced that the Society's 75th Anniversary Annual Meeting will occur in Chicago from August 8 to 10, 2025. The theme for the conference will be "Insurgent Sociology in a Time of Crises." The President introduced Assata Zerai as Program Chair and Committee Members Melanie E.L. Bush, Walda Katz-Fishman, and Rahsaan H. Mahadeo.

ITEM 16 - ADJOURNMENT OF THE BUSINESS MEETING

There being no further business, President Rose M. Brewer adjourned the 2024 business meeting.
